

Decision N<sup>o</sup> 3 of the Management Board of the European Foundation for the Improvement of Living and Working Conditions (Eurofound) on the confirmation of the appointment of the Accounting Officer of Eurofound

THE MANAGEMENT BOARD OF THE EUROPEAN FOUNDATION FOR THE IMPROVEMENT OF LIVING AND WORKING CONDITIONS (EUROFOUND),

Having regard to Regulation (EU) 2019/127 of the European Parliament and of the Council of 16 January 2019 establishing the European Foundation for the improvement of living and working conditions (Eurofound), and repealing Council Regulation (EEC) No 1365/75<sup>1</sup> (hereinafter referred to as the 'new Eurofound Founding Regulation'), and in particular Article 5(1)(m), 32 and 33 thereof,

Having regard to the Staff Regulations of Officials (hereinafter 'Staff Regulations') and the Conditions of Employment of Other Servants of the European Union (hereinafter 'CEOS') laid down by Council Regulation (EEC, Euratom, ECSC) No 259/68<sup>2</sup>,

Having regard to Eurofound's Financial Regulation<sup>3</sup>, and in particular Article 50 thereof,

## Whereas:

- (1) In accordance with the new Eurofound Founding Regulation, the Management Board appoints an Accounting Officer, covered by the Staff Regulations and the CEOS, who must be totally independent in the performance of his or her duties.
- (2) The Governing Board approved by written procedure<sup>4</sup> on 22 September 2009, the proposed appointment of the current holder of the post of Accounting Officer of Eurofound, which took effect from 23 September 2009, and informed the Budgetary Authority accordingly.
- (3) The entry into force of the new Eurofound Founding Regulation does not affect the rights and obligations of staff engaged under Regulation (EEC) No 1365/75.
- (4) The current holder of the post of Accounting Officer has an indefinite contract with Eurofound.
- (5) The members of the Governing Board established on the basis of Regulation (EEC) No 1365/75 remain in office and exercise the functions of the Management Board as referred to in Article 5 of the new Eurofound Founding Regulation until the appointment of the members of the Management Board and of the independent expert pursuant to Article 4(1) of that Regulation.
- (6) The appointment of the current holder of the post of the Accounting Officer of Eurofound by the Governing Board under Regulation (EEC) No 1365/75 remains valid

after the entry into force of the new Eurofound Founding Regulation and is reconfirmed by the Management Board,

## HAS DECIDED AS FOLLOWS:

The appointment of Mr David Maddocks, Temporary Agent (TA2(f), AST6) as Accounting Officer of Eurofound is hereby confirmed.

## Article 2

The present decision shall take effect on the day following that of its adoption.
