

Decision No 35 of the Management Board of the European Foundation for the Improvement of Living and Working Conditions (Eurofound) on the dates of Management and Executive Board meetings in 2021

THE MANAGEMENT BOARD OF THE EUROPEAN FOUNDATION FOR THE IMPROVEMENT OF LIVING AND WORKING CONDITIONS (hereinafter referred to as 'Eurofound').

Having regard to Regulation (EU) 2019/127 of 16 January 2019 establishing a European Foundation for the improvement of living and working conditions (Eurofound) and repealing Council Regulation (EEC) No 1365/75<sup>1</sup> (hereinafter referred to as 'Eurofound's Founding Regulation'), and in particular articles 8 and 10(6),

## Whereas:

- 1) In accordance with the Rules of Procedure of the Management Board and Executive Board the Management Board shall hold one ordinary meeting a year and the Executive Board shall meet three times a year.
- 2) In 2021 it is proposed to hold an additional Board meeting in the first quarter in consideration of the timeline for recruitment of the new Executive Director.
- 3) The Executive Board shall meet three times.

Article 2 - Entry into force
